SHOW SANCTIONING WORKING GROUP MEETING

Saturday, May 31, 2014

Mrs. Steinmetz reported that she has been discussing the proposed rule changes regarding gold shows. Suggestions include:

- Eliminate the number of ponies required for silver and bronze.
- Lower the number of ponies required for a gold show to 50.
- Increase the sanctioning fee to \$100 for single and \$200 for double-judged shows.
- Prize money would be increased from \$400 to \$600 uniformly across ten divisions.
- Overnight safe, adequate, onsite stabling for all exhibitors.
- A minimum of ten performance divisions. Additional pointed and or non-pointed classes.
- Twelve halter classes.
- A steward recognized by USEF or another organization or a WPCSA TD.

It was suggested that a clinic be held for TD's at the AGM.

We do not have a rule at this time regarding wire bits.

Carol Maurer requested that juniors not be allowed to show stallions. This decision needs to remain at the show level.

More points for regional and national shows have been requested frequently. This could go along with the changes for the gold and silver show. If the show is titled and has 100 ponies it could receive quadruple points. It was felt that if we do this, there should be no region that had two quadruple rated shows so we would drop the regional show from the region hosting the American National.

We need to amend Article 121.1.8 to state that the person MUST be capable of rendering assistance.

Allowing the supreme champions under both judges at the National and Regional titled shows to call themselves the National/Regional supreme champion was discussed.

Holding three performance classes in a row was discussed. It has been suggested that the pleasure classes be dropped to two classes with the conformation stake class receiving double points. The championship would still be decided based on points with the tie breaker being the stake class.

These suggestions will go to the regional reps, in the Review, email blast, Facebook and the chat list for discussion. Mrs. Steinmetz will write this for distribution.

1. Cherry Wilson has submitted a suggested rule change regarding the conduct of a judges. The following should be added to our rules: "A judge's conduct as a member, exhibitor, breeder, owner and judge, as well as his/her ability, must be exemplary. Each judges' status is subject to continual review by the Licensed Officials Committee and is revocable with or without notice and formal hearing.

 - Approved: Faye Tanner and Meg Willis. Ms. Willis to be reminded to not accept assignments for people with close affiliations.

3. The committee clarified that the rules should not require judges from other countries to pay a \$25 fee to judge.

MINUTES OF THE BOARD OF DIRECTORS' MEETING

Saturday, May 31, 2014

The Board of Directors' meeting of the Welsh Pony & Cob Society of America, Inc. was called to order by the President, Dr. Ruth Wilburn, at 2:30 p.m. on Saturday, May 31, 2014, at the Embassy Suites Hotel, Ashburn, Virginia. All Directors were in attendance as was Mrs. Landis, Executive Secretary-Treasurer.

I. President's Report

The President reported that she is having a toast to Lisa Landis for her 25 years of excellent service. She thanked the Board for all of their hard work and is pleased with the positivity the Board is generating.

II. Reading of the Minutes

Mrs. Stover's motion that we dispense with the reading of the minutes was unanimously adopted.

III. Secretary's Report

The Secretary's reported that there were three items for discussion. Linda Scherder has a pony with severe allergies and would like to make a notation on the Certificate of Registration. The Board felt that this should be stapled to the Certificate of Registration by Mrs. Scherder but not in the official description. It has been requested that when a person has a transfer of ownership form signed by the last recorded owner that the duplicate certificate authorization form be waived. The Board agreed that this can be changed. Finally, we have been contacted by Kim Misdeo of The Pony Habit regarding sponsorships of prizes and donation of auction items. She was referred to the Mrs. Steinmetz for Show Sanctioning and prizes and to Mrs. Stover for the auction. Mrs. Steinmetz reported there are several people who would like to be able to indicate that they are willing to take a pony back as the breeder or a previous owner. She will talk to the programmers about altering the Certificate of Registration. It was suggested that an asterisk be added beside the owner/breeder that would be willing to do this and then it be noted that "This person may be willing to rehome the animal."

IV. Treasurer's Report

Mrs. Verkuyl reviewed the Finance Committee Report (filed herewith). Ms. Cochran is willing to help promote the encouragement of member renewals. We are using USEF donations to build our video library on You Tube. Mrs. Aitken suggested we contact Cherry Wilson for a copy of the clinic she did at the AGM several years ago. We need to replace the shingles on the building. Ms. Cochran volunteered to do a drawing for the "raise the roof" campaign. Mrs. Verkuyl reported that raises have not been given since 2008 and that salaries needed to be discussed. Mrs. Landis noted that she did not require an increase. Ms. Himler's motion that the hourly employees receive a 25¢ per hour raise was unanimously adopted.

JOURNAL COMMITTEE REPORT

We have received a favorable quote from Winchester Printers for the new format (full color, stapled) of the Journal (formerly the yearbook). I did not have any success in receiving a quote from the company that prints the Maryland Pony Breeders directory, in spite of many, many phone calls, which were never returned, nor would they respond to e-mail.

We currently have commitments for 25 full page ads, 4 half pages ads and approximately 55 winner’s photos, for a total of 57½ paid pages. We have not yet solicited ads for 2013, but will go forward with that as soon as the pricing is approved. The deadline for additional ads and 2013 winner’s photos will be July 1st.

I am proposing the following fees, which will more than cover the cost of printing, and should easily cover the postage costs as well:

Full page: \$110

Half page: \$70

Winner’s photos: \$50 each

Covers: \$200

I believe that the lowering of prices will cause more people to be interested in participating in advertising in the Journal, which will allow a much more timely publication in the future. At the above pricing, with just what we have submitted so far, all costs are already more than met.

It is my goal to have the Journal complete and to the printer’s by September 1, 2014, which will allow us to solicit ads for the 2014 journal early in 2015, and get the Journal back on schedule.

The WPCSA Election Results

Equine Metabolic Syndrome & Laminitis Presentation – Focus on Welsh Ponies

In a continuing effort to support equine research, the Welsh Pony and Cob Foundation (WPCF), through the Maureen Lapicola Equine Research Fund, is helping fund research projects that commonly afflict ponies and cobs. The Society was pleased to have Dr. Molly McCue, Associate Professor of Equine Medicine at the University Of Minnesota College Of Veterinary Medicine and research partner Dr. Elaine Norton share results of an Equine Metabolic Syndrome (EMS) study funded in part by the WPCF. The recently completed study includes data from more than 600 horses, including 100 Welsh ponies. Data from this study has led to new insights into EMS and its characteristics between breeds. The presentation focused on findings specific to Welsh ponies and how the research group is working to identify the underlying genetic factors that increase risk for the development of EMS.

WPCSA Judges Clinic on Welsh Movement

Joann Williams, owner of JPW Dressage Training, WI, presented a clinic to WPCSA judges and judge applicants on linking breed type to movement, conformation and soundness. The clinic was very informative, with many slides and illustrations, including videos of the various gaits with explanations of why certain movements were hard to train because of conformation. Ms. Williams has 30 years' experience as a trainer and equine consultant. She is a USDF gold medalist on a self-trained horse, has earned all six USDF medals and is a WPCSA approved 'R' judge.

The WPCSA Foundation Scholarship

The Society is pleased to announce that Meg and Emily Gill of Loafers Lodge Welsh Ponies in Monkton, Maryland are once again recipients of this year's educational scholarships. Each of these college students will receive a \$500 scholarship from the Molly Butler/J.D. O'Rear Memorial Scholarship Fund. Selected from a group of 15 candidates, Meg and Emily exemplify the original purpose of the scholarship initiative – to support deserving students with an equine background. As third generation Welsh pony owners, breeders, exhibitors, and life members of the WPCSA, Emily and Meg have grown up surrounded by the Welsh community. Both are actively involved in the training, producing and showing of the family's ponies throughout the nation and meeting with great success. In presenting these scholarships, Mrs. Sabra Schiller, Board member and Chair of the Scholarship Committee stated, "even though these young ladies have been scholarship recipients in the past, they stood head and shoulders above the rest." Meg is currently a junior at Stevenson University, studying Forensic Accounting. Emily is also in her junior year and is studying Elementary Education at Goucher College. A heartfelt congratulation goes out to both of these outstanding young adults from the WPCSA!

Welsh of the Year Announced!

The Welsh Pony & Cob Society of America is pleased to announce that Section D Welsh stallion, North Forks Brenin Cardi is this year's recipient of the Welsh of the Year Award. Cardi is owned by Cindy Miller, Winterlake Farm, Pleasant Hill, OR and trainer/rider Jessica Wisdom, Equi-Librium Equestrian, OR.

In 2013, seven nominees were submitted for Welsh of the Year, all of which were selected by committee to run for the award. WPCSA membership then voted a tightly contested competition culminating in the selection of the top winner awarded at Society's annual meeting in February. The nominees demonstrate the versatility of the Welsh breeds and their successes in and out of the show ring. This program, started in 2012 is designed to promote ownership, encourage involvement and spotlight the achievements of extraordinary Welsh breed individuals and Cardi certainly exemplifies that!

Cardi began his dressage career as a three-year old in 2004 at Training Level and ended that season with his first of several Regional Championships. Since 2004, Cardi and co-owner/rider Jessica Wisdom progressed through the levels and they continued to win. The journey with Cardi has covered 3,000 miles to Devon in Pennsylvania, and 1,000 miles to Southern California to compete at the highest level of dressage, the CDI competitions, which includes European riders and horses. Both pony and rider entered their first Intermediare II and Grand Prix classes at the Festival of the Horse in California in 2012. Last season the I-II, Grand Prix, and GP Freestyle tests, resulted in Cardi winning 12 Firsts, one Second, one Third, and one Fourth place. The season ended by scoring a 73% and winning the Grand Prix Freestyle at the Oregon Dressage Society Championship Show. In April Cardi competed for the first time at Grand Prix in a CDI at San Juan Capistrano and scored a best of 68%. The following weekend at Rancho Murieta, Golden State Dressage, Cardi won the CDI Grand Prix freestyle. Cardi was also showcased at the WPCSA AGM clinic, entertaining dozens of AGM attendees and performing an outstanding Grand Prix Freestyle as part of clinic's "elements of dressage."

Cardi has become a popular ambassador for the breed. The fact he has never had shoes and is happier in a snaffle than a double bridle, makes him quite the anomaly among towering warmbloods. And people love all the hair! He has graced the covers of Flying Changes and Northwest Inc., the Welsh Yearbook, The Review and been the subject of articles or had photos in Dressage Today, Massachusetts Horse, Warmbloods Today, USDF Connection and Equestrian magazines.

As a prepotent stallion, Cardi has produced exceptional sport babies. From coast to coast, his offspring are now competing in dressage, eventing, and driving and excelling. Once again, congratulations to Team Cardi on this spectacular honor!
