RULES & REGULATIONS In Addition to the General Rules of the WPCSA

- 1. **ELIGIBILITY:** This show is open to ponies registered with and foals eligible for registration with the Welsh Pony and Cob Society of America. Person making entry and the eligibility of the animal shall be subject to the rules of the WPCSA and the Local Competition.
- 2. Payment of Fees: Only Cash, Checks or Money Orders payable in U.S. Currency will be accepted. A \$25.00 fee will be assessed for Non-Negotiable Checks. Fees must be paid in full with paperwork and signatures complete before numbers will be issued.
- 3. Entries: Must be postmarked no later than April 12, 2017 to be accepted. NO POST ENTRIES ACCEPTED. All entries require Negative Coggins taken within one year of the date of the show. Copy of Pony Registration Papers and Measurement Cards MUST BE attached to the entry form. Incomplete entries will not be processed and will be returned.
- 4. Fees:

Double Judged Breeding, with WPCSA fee \$40.00 Performance Classes \$15.00 WPCSA recording fee, performance only \$5.00

- **5. Number Fee:** The number you are given will be your number for all the Shows in the 2017 PC Silver Series. You may turn in your number at the end of the show, where it will be put in your folder awaiting the next show. If you lose your number, you will be charged a fee of \$10.00.
- **6. Scratches:** Entry Fees (minus a \$10.00 fee per animal) will be refunded by mail ONLY UPON THE PRESENTATION OF A VET'S CERTIFICATE AND NOTIFICATION TO THE SHOW SECRETARY before the start of the show.
- 7. **Prize Money:** The prize money for this show totals \$240.00. \$10 will be given for each judge in the following divisions: Champions of Section A and Section B Fillies, Colts, Stallions, Mares and Geldings; Grand Champions of Sections C/D and Half Welsh.
- **8. Ribbons:** No ribbons will be given. All classes will be placed 1st to 4th. Look for results to be available on line after the show.
- **9. Height and Measurement:** All entries age 6 and over must present a measurement Card from the USEF or WPCSA or be measured before getting your numbers to show.

All ponies in performance classes must have a measurement card. Measurement will Take place at 8:00am on the day of the show. Non WPCSA members must pay a \$5 non member measurement fee.

Coggins/Rhino: A negative Coggins test certificate, or copy thereof, within one year of the show is **required**. A vaccine for Equine Rhinopneumonitis within 90 days of the show is **strongly recommended**.

- 10. Dogs: Please leave your dogs and other pets at home. If they come, they Must be on a leash or crated.
- 11. Bathing Ponies: This facility has no place for you to bathe your ponies.
- **12. Motorized Vehicles:** There will be no motorized vehicles such as golf carts or scooters allowed on the grounds.
- 13. Protective Head Gear: Protective head gear must be worn by all mounted riders at all times.
- **14.** Classes may be divided at show management's discretion if entries warrant (4 ponies each split for performance)
- 15. Food: You will need to bring your food and drinks.
- 16. Stabling: Please note that there is NO stabling available for the show.
- 17. Junior exhibitors must wear approved protective headgear (ASTM/SEI) at all times whenever mounted or in a driven vehicle at all times while on the show grounds. Harness must be secured and properly fitted. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place.
- 18. Every precaution will be taken for the safe keeping of every animal and article upon the grounds. Show management, WPCSA, employees, officials, volunteers or the Equestrian Center of Harford County,Inc. will in no case be responsible for any damage or accident which may occur. Each exhibitor will be solely responsible for their own liabilities if incurred, as well as damage or injury to any other person or property, caused by the exhibitor or any of the animals exhibited by him/her.
 - 19. For animals in harness, animals must be fully bridled while hitching and unhitching. Removing the bridle from an animal harnessed to a vehicle, or leaving an animal unattended while hitched; anywhere on the show grounds will result in instant elimination and removal from the show grounds.

The show qualities of the animal shall not be considered, although cleanliness and grooming can be considered. Exhibitors enter to the left so as not to obscure the judge's view. The judge evaluates the ability of the junior to follow directions, use space wisely, and execute the requested patterns. Juniors should appear "ring wise", be alert to the judging progression and be prepared for changes in the judging routine.

Classes open to riders 7 & under mounted on Ponies/Cobs / Half-Welsh/Part Breds, mares and geldings. See rules for attachment of leading rein. No chain leadlines allowed. Judged on equitation and suitability of mount at a walk. To stand quietly. To be led by an adult or a junior age 12 or over. Both handler and rider to be appropriately attired. English or

Western attire is acceptable. No chain leadlines. **RIDERS** ineligible for other ridden classes except costume, leading rein, leadline walk-trot, and leadline walk-trot poles.

46. WPCSA LEADLINE WALK-TROT (Article 115.4)

Classes open to riders 7 & under mounted on Ponies/Cobs / Half-Welsh/Part Breds, mares and geldings. See rules for attachment of leading rein. No chain leadlines allowed. Judged on equitation and suitability of mount at a walk and trot/jog. To stand quietly. To be led by an adult or a junior age 12 or over. Both handler and rider to be appropriately attired. English or Western attire is acceptable. No chain leadlines. **RIDERS** ineligible for other ridden classes except costume, leading rein, leadline walk and leadline walk-trot poles.

47. WPCSA LEADLINE WALK-TROT POLES (Article 115.4)

Classes open to riders 7 & under mounted on Ponies/Cobs / Half-Welsh/Part Breds, mares and geldings. See rules for attachment of leading rein. No chain leadlines allowed. Judged on equitation and suitability of mount. To be ridden once around a course of four poles on the ground entirely at a walk or entirely at a trot/jog. Poles are to be placed at a minimum of 4 feet off the rail, two on each side of the ring, simulating a hunter course. The poles should be placed far enough away from the entrance gate to provide an adequate sized area to do an opening and closing circle. To be led by an adult or a junior age 12 or over. Both handler and rider to be appropriately attired. English or Western attire is acceptable. No

chain leadlines. **RIDERS** ineligible for other ridden classes except costume, leading rein, leadline walk and leadline walk-trot.

48. WPCSA LEADING REIN: Section A, B, C or Partbred/Half Welsh, mare or gelding, 12.2 hands and under, to be ridden by junior exhibitors at least four, but not more than eight years of age. Ponies to be judged on manners, suitability, breed type, conformation and turn-out. This is not an equitation class. There are no restrictions for the pony or rider.

49. WPCSA WALK (Article 115.5)

Classes open to riders 11 & under mounted on Ponies/Cobs / Half-Welsh/Part Breds, mares and geldings. Judged on equitation and suitability of mount. English or Western attire is acceptable. **RIDERS** ineligible for other ridden classes except costume, leading rein, child's first pony, walk-trot and walk-trot poles. To walk both ways of the ring.

50. WPCSA WALK-TROT (Article 115.5)

Classes open to riders 11 & under mounted on Ponies/Cobs / Half-Welsh/Part Breds, mares and geldings. Judged on equitation and suitability of mount. To walk and trot/jog both ways of the ring. Possible test to include: walk, trot/jog, turn, halt and rein back at spots marked. English or Western attire is acceptable. **RIDERS** ineligible for other ridden classes except costume, leading rein, child's first pony, walk and walk-trot poles.

51. WPCSA WALK-TROT POLES (Article 115.5)

Classes open to riders 11 & under mounted on Ponies/Cobs / Half-Welsh/Part Breds, mares and geldings. Judged on equitation and suitability of mount. To be ridden once around a course of four poles on the ground entirely at a walk or entirely at a trot/jog. Poles are to be placed at a minimum of 4 feet off the rail, two on each side of the ring, simulating a hunter course. The poles should be placed far enough away from the entrance gate to provide an adequate sized area to do an opening and closing circle. English or Western attire is acceptable. **RIDERS** ineligible for other ridden classes except costume, leading rein, child's first pony, walk and walk-trot.

52.WPCSA CHILD'S FIRST PONY: Section A, B, C, and partbred/Half Welsh, mare or gelding 12.2 hands and under, to be ridden by junior exhibitors at least four, but no more than 10 years of age. Riders to be suitably dressed in Hunt, Saddle or Western attire including protective headgear. Ponies to shown at a walk and trot or jog, both ways of the ring. Ponies to be judged on performance, manners and suitability. Conformation, way of going, manners, suitability and turnout to be emphasized. This is not an equitation class. There are no restrictions for the pony or rider.

53. WPCSA WALK-TROT ADULT EQUITATION Class open to riders 18 years of age and older on ponies, cobs, Half-Welsh or Part Breds. English or Western Attire is acceptable.

Riders ineligible for any other WPCSA pointed ridden class at that show. Judged on equitation and suitability of mount. To walk and trot or jog both ways of the ring. Possible tests to include: walk, trot or jog, turn, halt and rein back at spots marked.

WPCSA ENGLISH PLEASURE: To be shown at a walk, trot and canter both ways of the ring on light contact without martingale. To be judged 75% on performance, manners, movement and style; 25% on breed type and conformation. Working classes are judged 100% on performance
